SCIOTO COUNTY COURT OF COMMON
PLEAS, GENERAL DIVISION

OF THE SEPTEMBER TERM, THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that:

COUNT ONE: SEXUAL BATTERY, F3

On or about October 1, 2024 through June 1, 2025, at Scioto County, Ohio, DAMION QUAZA COLEMAN, unlawfully, did engage in sexual activity with Z.A. 10/21/2009; cause Z.A. 10/21/2009 to engage in sexual activity with him; or cause two or more other persons to engage in sexual activity while DAMION QUAZA COLEMAN was a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the director of education and workforce prescribes minimum standards pursuant to division (D) of section 3301.07 of the revised Code, Z.A. 10/21/2009 was enrolled in or attended that school, and defendant was not enrolled in and did not attend that school and the sexual activity involved was sexual conduct.

in violation of Ohio Revised Code §2907.03(A)(7), 2907.03(B)(1), and against the peace and dignity of the State of Ohio.

COUNT TWO: PANDERING OBSCENITY, F5

On or about October 1, 2024 through June 1, 2025, at Scioto County, Ohio, DAMION QUAZA COLEMAN, unlawfully, did, with knowledge of the character of the material or performance involved, buy, procure, possess, or control any obscene material with purpose to violate Section 2907.32(A)(2) or 2907.32(A)(4) of the Ohio Revised Code.

in violation of Ohio Revised Code §2907.32(A)(5), and against the peace and dignity of the State of Ohio.

COUNT THREE: PANDERING OBSCENITY, F5

On or about October 1, 2024 through June 1, 2025, at Scioto County, Ohio, DAMION QUAZA COLEMAN, unlawfully, did, with knowledge of the character of the material or performance involved, create, reproduce, or publish any obscene material, knowing that such material was to be used for commercial exploitation or that such material would be publicly disseminated or displayed, or DAMION QUAZA COLEMAN was reckless in that regard.

in violation of Ohio Revised Code §2907.32(A)(1), 2907.32(C), and against the peace and dignity of the State of Ohio.
